



STUDENT CAMPUS PARKING PERMITS

There are not enough parking spaces on campus for all students to have an individual parking space. The number of parking tags reserved will correspond to the number of parking spaces available to students. Seniors have priority in receiving parking spaces. No student with a birth date after 9/1/2001 will be considered for a parking space; until those with prior birthdates have been accommodated. Spaces will be filled in the order applications are received with the following priorities:

- A. Seniors with carpools consisting of driver plus 3 students, or vehicle's capacity (may include DLS students) and have complied with the deadline of **May 1, 2017**.
- B. Seniors with carpools consisting of driver plus 2 students (may include DLS students) and have complied with the deadline of **May 1, 2017**.
- C. Seniors with carpools consisting of driver plus 1 student (may include DLS students) and have complied with the deadline of **May 1, 2017**.
- D. If any spaces remain after the carpools have been accommodated, remaining spaces will be available to seniors first and then juniors on a first come, first served basis, based on the date your application was received.

All registration paperwork must be submitted before parking applications will be considered. Parking tags and parking reservations are not transferable. Loss or transfer of tag may result in loss of parking privilege. Students may not change parking spots without approval of the Deans. Due to the addition of compact spaces, please use page 2 of the motor vehicle registration to list all cars that may be driven during the year. Applications must be received no later than **May 1, 2017**. Parking permits may not be picked up until Orientation Day. Please be prepared to show a valid driver's license. There are fewer parking spaces than students who need them. If you find you do not need your space, please notify the Dean so a student from the waiting list can be accommodated.

Any abuse of these accommodations will result in the loss of your parking privileges for the remainder of the school year.

Sophomores are not permitted to park on campus.
